Registration Fee of \$20 per child, \$10 each additional; non-refundable.

2026-2027 Cancellation/Withdraw Class Policy

- **Cancellation Policy: During the months of Sept - Dec 2026**, In order to withdraw your child from class you must notify in writing, refunds will not be given within the month so enjoy the rest of the month's classes. If costume fee has been paid it is non-refundable. **Beginning March 1, 2027** if you wish to withdraw, you will be responsible for the remaining tuition payment thru June 2027 (see Gia for details).
- **Class Drop Policy Gem Dancers Only:** The last day to withdraw without penalty from a GEM Class is September 30th. After that date, if you choose to withdraw from a GEM class you will be responsible for paying the remainder of your agreed upon tuition for the calendar year in which you withdraw.
- For those who want to hold their spot in the class but have another commitment until fall sports season is over you can enroll, pay registration fee and pay the monthly tuition to hold your spot.

2026-2027 Dance General Policies

Dance Year is September – June.

The Dance Center of Danvers Rules: No Running, Fighting, Horse-play in the facility. No leaving the facility unless accompanied by an adult/permission. No gum in the facility. No yelling or vulgar language in the facility. Not liable for injury, stolen property, etc. Do not touch Dance Center equipment.
